

**Eckrich® 2019 College Football \$1M Challenge**  
**Official Rules**

**NO PURCHASE NECESSARY. **1. Eligibility:** Eckrich® 2019 College Football \$1M Challenge (the "Sweepstakes") is open only to legal residents of specific states (as outlined below in Section 3) within the fifty (50) United States and the District of Columbia who are at least the age of majority in their state of residence at the time of entry: eighteen (18) in most states; 19 in Alabama (AL) and Nebraska (NE) and 21 in Mississippi (MS) at the time of entry. Administrator's computer is the official time-keeping device for the Sweepstakes.

**4. How to Enter the Match Up Entry Period(s) and the National Championship Game Entry Period:**

If you are a college student, enter the state location of your university or college that you are attending during the college football season. You automatically will receive one (1) entry into the National Championship Game drawing and one (1) entry into any applicable Entry Period drawing that you are eligible for based on the table in Section 3 above.

Limit: Each entrant may receive one (1) entry into the National Championship Game drawing per day during the Promotion Period; each entrant may receive one (1) entry per day during the Promotion Period for each Entry Period he/she is eligible. Multiple entrants are not permitted to share the same email address. Any attempt by any entrant to obtain more than the stated number of entries by using multiple/different email addresses, identities, registrations and logins, or any other methods will void that entrant's entries and that entrant may be disqualified. Use of any automated system to participate is prohibited and will result in disqualification. **Earn Bonus Sweepstakes Entries into Match Up Entry Period 8 Drawing**: Only entrants eligible for Match Up Entry Period 8 may earn bonus entries, as outlined below:

**5. Prize Drawings**: Co-Administrator is an independent judging organization whose decisions as to the administration and operation of the Sweepstakes and the selection of the potential winners are final and binding in all matters related to the Sweepstakes. **\*\*Details for the opportunity to win \$1,000,000:** Winners are responsible for all transportation to and from the applicable event.
